DIRECTIONS

From I-95 to Showgrounds – from I-95 take exit #66 (Forest Hill Blvd). Travel west on Forest Hill Blvd for 11 miles to South Shore Blvd. Turn left on South Shore Blvd, entrance is on South Shore before you reach Pierson.

From FL Turnpike to Showgrounds – from FL Turnpike take Exit #93 (Lake Worth Rd), turn right and go 5 miles until road ends, turn right on South Shore Blvd, go past Pierson Rd, entrance is the next right after Pierson.
