ABOUT THE USEF OPPORTUNITY FUND ==

US Equestrian recognizes "Community Outreach Organizations" that provide equine-based learning opportunities and support the positive impact horses can have in their local communities.

The USEF Opportunity Fund is the grant-making branch of the Community Outreach Program that will support a competitive grant process available exclusively to recognized USEF Community Outreach Organizations.

Any USEF Community Outreach Organization interested in applying for a grant must submit a grant request for review and selection. This is a competitive grant process, so a grant is not guaranteed.

USEF Community Outreach
Organizations are eligible to apply
for USEF Opportunity Fund grants to
support their organization and funds are
not limited to programming initiatives
(i.e. staff pay, facility improvements,
feed, etc.). All grant recipients must use
those funds for their stated purpose in
the application and will be expected to
provide reports at six-month intervals
using Key Performance Indicators (KPIs)
or other key measures of progress
per grant request.

WHAT TO INCLUDE IN YOUR GRANT REQUEST ===

I. Executive Summary

Please provide an executive summary of your grant request and your organization's mission. Describe your offered programs and your reach, who your organization serves and how, etc.

II. Need Statement

Please detail the dollar amount requested and why you are seeking a grant. In what ways or areas will this grant support the organization? What challenges is your organization facing that could be alleviated by this grant? Who will this grant support?

III. Goals & Objectives

Tell us how this grant will be used, your goals for this project/program, and how you intend to implement these goals using KPIs or other relevant measures of success for your organization's request.

IV. Other Funding Sources and Sustainability

Demonstrate how this grant fits in with your organization's existing sources of income. Describe your current fundraising channels and strategies to have sustainable sources of finances.

V. Project Budget Outline

Provide a timetable for how you plan to implement this grant, as well as measure its impact, starting from date funded.

VI. Medium

This grant request is an opportunity to submit something creative that can help us get a better understanding of your organization. It can come in any form: essay, artwork, video, PowerPoint presentation, blog post, etc. The sky is the limit!

O3DOCUMENTS TO SUBMIT

To apply for a grant, your organization will need to provide several additional documents regarding its nonprofit status and finances.

You'll need:

- Last two most recent years of:
 IRS Form 990
 Audited Financials
- 2021 W-9
- Most recent Annual Report and/or Strategic Plan
- Most recent financial statements



O4 HOW TO SUBMIT A GRANT REQUEST ==

Submitting a Grant Request will be done in TWO simple steps:

- 1) Upload all of the required files to a third party file transfer platform, such as: WeTransfer, Google Drive, Dropbox
- **2)** Email the link to your files to: DEIFeedback@usef.org with the subject:

[Org name - Opportunity Fund Grant Request]

Please submit all grant request materials in one email. Please utilize a third-party file transfer platform and do not attach files to your submission email. Emails with large attachments are at an increased risk of "bouncing back" and being undeliverable to USEF.

March 15, 2023: Grants open

April 15, 2023: Submissions for grant requests are due by 5:00 p.m. ET

May 15, 2023: Notification of request for an individual interview with members of the Review Committee

June 15, 2023: Interviews completed

June 23, 2023: Final decisions completed by USEF and grant recipients to be notified of decision

June 28, 2023: USEF announces 2023 grant recipients
