Any and all images and videos taken while on site may solely be used in relation to my assignment. In the event I am found in violation of this request, my media credentials will be immediately revoked and I will be asked to leave the competition grounds, as well as prohibited at all US Equestrian National Championships.

With respect to video broadcast rights, the USEF retains the sole video broadcast rights from the field of play. Broadcast or sale of video plays of competition rides will be strictly prohibited without written consent from USEF. Videoing outside the field of play, such as for interviews, is acceptable, as long as it does not interfere with the competition.
