DIRECTIONS

<u>From Denver International Airport (DEN) to Hotels</u> – Head north on Peña Blvd. Get on E-470 S in Adams County from E 75th Ave, Jackson Gap Rd and E 56th Ave. Follow E-470 to Cottonwood Dr in Parker. Turn right onto Cottonwood Dr.

<u>From Denver International Airport (DEN) to the Colorado Horse Park</u> – Take Peña Blvd. 4.4 miles to exit 6A toward I-70 S, keep left and merge onto E-470 S for 22 miles. Take exit 5 for CO-83 S/S Parker Rd and turn left. The showgrounds will be on the left.

<u>From Hotels to the Colorado Horse Park</u> – Head south on Cottonwood Dr. At the traffic circle, take a 1st exit onto Crown Crest Blvd. Use the left two lanes to turn left onto CO-83 S/S Parker Rd/N State Hwy 83. Use the left two lanes to turn left onto turn left onto Baylou Gulch Rd.
