- Discount registration deadline is May 4, 2018.
- Clinic may be subject to cancellation if sufficient interest has not been established 45 days prior to the clinic.
- Attendance sheets must be signed at each session to receive credit for the clinic. If you arrive more than one hour later than the scheduled starting time, or leave more than one hour earlier than the scheduled adjournment, you will not receive credit for attending the clinic.
- We will email or fax a confirmation of receipt of your completed application. Online registrations receive immediate confirmation on the web page, no additional email will be sent.

### DIRECTIONS

From Denver International Airport (DEN) to Hotels – Head north on Peña Blvd. Get on E-470 S in Adams County from E 75<sup>th</sup> Ave, Jackson Gap Rd and E 56<sup>th</sup> Ave. Follow E-470 to Cottonwood Dr in Parker. Turn right onto Cottonwood Dr.

From Denver International Airport (DEN) to the Colorado Horse Park – Take Peña Blvd. 4.4 miles to exit 6A toward I-70 S, keep left and merge onto E-470 S for 22 miles. Take exit 5 for CO-83 S/S Parker Rd and turn left. The showgrounds will be on the left.

From Hotels to the Colorado Horse Park – Head south on Cottonwood Dr. At the traffic circle, take a 1<sup>st</sup> exit onto Crown Crest Blvd. Use the left two lanes to turn left onto CO-83 S/S Parker Rd/N State Hwy 83. Use the left two lanes to turn left onto Baylou Gulch Rd.
