DIRECTIONS

From Chicago O’Hare International Airport (ORD) to Hotels – take I-190 E then merge onto I-294 S for 6.3 miles (partial toll road), take I-290 W for 6.4 miles, take exit 7 for I-355 S for 4 miles (partial toll road), take exit for IL-64/North Ave. and turn right, go 12.6 miles, turn right on Kirk Rd, then left on Foxfield Rd.

From Chicago Midway International Airport (MDW) to Hotels – take S. Keating Ave right, then slight right onto S. Cicero Ave. for 5.6 miles, turn left on W. Flournoy St, take ramp on left onto I-290 W for 8.2 miles, continue onto I-88 W (signs for S. Tollway/Aurora/I-294 W), take IL-38 W/E Roosevelt Rd. for 6.6 miles, take I-355 N for 3 miles (toll road), take IL-64/North Ave exit, slight left at toll booth, then take first left onto IL-64 W/E North Ave for 12.7 miles, turn right on Kirk Rd, then left on Foxfield Rd.

From Hotels to Lamplight Equestrian Center (4 miles) – go west on Foxfield Dr, right on Dunham Rd, then go left at the T. Lamplight is on left approx. 1.5 miles after Army Trail Rd., 6N940 Dunham Rd, Wayne, IL 60184.
