DIRECTIONS

Bluegrass Airport to Hotel- exit airport left onto Man O' War Blvd, turn right on Versailles Rd, take ramp onto New Circle Rd North, take Exit 9B for KY-922 N/Newtown Pike towards interstate, turn left and take a right on Stanton Way, hotel is at the end of the road on the left.

From North (Cincinnati) to Hotel - take I-75 South to exit 115 Newtown Pike KY-922, turn left on Newtown PK, turn left and take a right on Stanton Way, hotel is at the end of the road on the left.

From West (Louisville) to Hotel - take I-64 East to exit 115 Newtown Pike KY-922, turn left on Newtown PK, turn left and take a right on Stanton Way, hotel is at the end of the road on the left.

From Fairfield Inn to USEF - turn right on to Newtown Pike, go 2 miles and turn left on Iron Works Pike (4-way stop), use KY Horse Park main entrance (past the campground entrance). Bear right out of the roundabout and proceed until the road turns left. USEF is the second building on the right. Please park in the parking area directly across from building.
