- Clinic may be subject to cancellation if sufficient interest has not been established 45 days prior to the clinic.
- Attendance sheets must be signed at each session to receive credit for the clinic. If you arrive more than one
  hour later than the scheduled starting time, or leave more than one hour earlier than the scheduled
  adjournment, you will not receive credit for attending the clinic.
